

# HAIR/MAKEUP SERVICE

## CONTRACT

### Services Provided

The Makeup Artist agrees to provide makeup services to the Client for the following event Wedding Booking. The specific makeup services to be provided shall be agreed upon by both parties and outlined in the attached schedule or separate written agreement. The Makeup Artist shall use their professional expertise and skills to provide high-quality makeup services to the Client.

### Payment Terms

The Client agrees to pay the Makeup Artist the total amount of 30% of the price for the makeup services provided. A non-refundable deposit of cancel less than 12 weeks before the booking day is required to secure the Makeup Artist's services. The deposit shall be paid by the Client to the Makeup Artist no later than 12 weeks before the wedding day. The remaining balance shall be paid by the Client to the Makeup Artist on or before the day of the event(s).

In the event of cancellation by the Client, the deposit shall not be refunded to the Client. The Makeup Artist's fees include the provision of makeup products, tools, and equipment necessary for the makeup services.

### Client's Obligations

The Client shall provide a clean and well-lit workspace for the Makeup Artist to perform the makeup services. The Client shall ensure that any allergies, sensitivities, or special requirements are communicated to the Makeup Artist in advance. The Client shall provide any necessary electrical outlets and adequate lighting for the Makeup Artist's equipment. The Client shall ensure that there is sufficient time and access for the Makeup Artist to complete the makeup services.

### Makeup Artist's Obligations

The Makeup Artist shall use their professional expertise to provide high-quality makeup services to the Client. The Makeup Artist shall use sanitary practices and high-quality makeup products. The Makeup Artist shall strive to complete the makeup services within the agreed-upon timeframe. The Makeup Artist shall bring their own makeup kit, including brushes, tools, and equipment, unless otherwise agreed upon. The Makeup Artist shall make reasonable efforts to accommodate any reasonable requests or preferences of the Client regarding the makeup services.
